



Education Committee Report





Spring meeting on March 26 was held at Cyprian Keys Gold Club in Boylston. The program featured Melissa Couture Rimbold M.A.A, Assessor, Town of South Hadley. Melissa outlined an Assessor's Monthly Calendar of events. The session explained cyclical procedures performed by an assessor's office on a monthly basis. Next up was Christopher Keefe, R.M.A, M.A.A, Principle Assessor, Town of Wilbraham. Christopher outlined topics and trends emerging from recent Income and Expense filings involving lease types, Cap Rates, extraneous reported expenses and accounting for building improvements and fit up. The last presentation of the day was completed by Richard Conti, A.S.A, ARM/PP, M.A.A, Board of Assessors Chairman, City of Taunton. Richard outlined Everything you need to know about Personal Property assessment. The class included a fabulous luncheon buffet.

The Spring Clerks Meeting took place on June 6th at the newly constructed Shrewsbury Police Station Training Room. The first session was taught by William B.

Mitchell, RMA, M.A.A, and Chief Assessor for North Andover. The session outlined everything you want to know about entering deeds including coding sales, identifying parcels and recording ownership changes. The afternoon session was presented by James F. Crowley, Tax Counsel, Bureau of Municipal Finance Law, Division of Local Services, Department of Revenue. James discussed Trusts and Life Estates and how they apply to Exemptions, ATB case law and an update on the Tyler Case. The format included an informative question answer session and a fantastic lunch! The final fall session class on October 9th took place at the updated Upton Community Center and Library. It was an Excel class taught by David Cornell, MAI, and CAE certified Excel Expert. The class covered the use of Excel and was linked specifically to the needs of an assessor's office.

All classes were very well attended and provide a wonderful opportunity to network with other assessing professionals from Worcester County and beyond. Don't forget, if you are short on finance, please apply for a scholarship; the funding is there for you to use, so please take advantage of the opportunity.

REMINDER: SCHOLARSHIPS ARE AVAILABLE!



The Worcester County Assessors Association has available funds for scholarships. To apply you only need to be a paid member of the WCAA. The scholarships are available to new and seasoned office staff and Assessors. A community may not receive more than one scholarship in a given year. The maximum amount of any awarded scholarship cannot exceed \$250. The scholarships are available for the summer conference and the classes offered at the ANNUAL SCHOOL each summer. However, a scholarship can only be used for tuition not room and board.

If you have a financial need for a scholarship, please complete an application (found on WCAA's web site www.wcaa-ma.org) and send the completed application to the address listed at the bottom of the application. The on-line application is a fillable form.

Legislative Update

THE HERO ACT - Updated Legislative Information Please see the updated summarized information on The Hero Act provided to you by your legislative co-chairs. AN ACT HONORING, EMPOWERING, AND RECOGNIZING OUR SERVICEMEMBERS AND VETERANS ("HERO" Act) CHAPTER 178 OF THE ACTS OF 2024, EFFECTIVE AUGUST 8, 2024 MUNICIPAL TAX PROVISIONS

Section 23 Property Tax Exemptions Section 23 adds two new veteran property tax exemption clauses, Clauses 22I and 22J, to General Laws, c. 59, §5, which is the statute that establishes local property tax exemptions for individuals and organizations. Both new clauses are local options that must be accepted by a city or town to apply in that municipality.

Acceptance requires a vote of the legislative body of the municipality (town meeting, town council or city council) subject to the municipality's charter. G.L. c. 4, § 4. Clause 22I, if accepted, would increase the amount of the tax exemption granted to veterans on their domiciles under Clause 22, Clause 22A, Clause 22B, Clause 22C, Clause 22E and Clause 22F annually by a cost-of-living adjustment (COLA) determined by the Department of Revenue (DOR) based on the consumer price index. This would work like the annual COLA adjustment determined by DOR that is already a local option for certain senior exemption amounts and financial means standards. See G.L. c. 59, § 5, C lauses 17E, 17F and 41D. Clause 22J, if accepted, provides an additional exemption up to 100% of the amount of the tax exemption granted to veterans on their domiciles under Clause 22, Clause 22A, Clause 22B, Clause 22C, Clause 22E and Clause 22F.

This would work like the optional additional exemption that is already a local option under G.L. c. 59, § 5C½ for all persons granted exemptions on their domiciles as veterans. seniors, blind persons, and surviving spouses. Clause 22J will not apply in a year in which the city or town already uses G.L. c. 59, § 5C½ to grant an additional exemption to all persons granted exemptions. It is an option for cities and towns that do not use that general additional exemption to be able to just grant one for persons granted veteran exemptions. As with the general additional exemption, the application of the Clause 22J additional exemption cannot reduce the tax owed below what the taxpayer would owe on 10% of the current assessed valuation of the domicile.

To implement, the city or town must vote to accept the statute and establish the additional exemption percentage before the July 1 beginning of the fiscal year that percentage will first apply. The voted percentage will continue to apply in subsequent years unless and until another percentage is voted before the July 1 beginning of a later fiscal year.

Section 24 Motor Vehicle Excise Exemption

This section changes how eligibility for the motor vehicle exemption for a veteran with a permanent service-connected disability is established under G.L. c. 60A, § 1.

Currently, the Medical Advisory Board within the Registry of Motor Vehicles (RMV) determines that the veteran has the disability. Under the amendment, effective immediately, eligibility will be based on a disability determination by the U.S Department of Veteran Affairs (VA), as is the case with other motor vehicle and property tax exemptions available to veterans.

Section 151 Property Tax Exemption Study This section directs the MA Executive Office of Veteran Services, in consultation with DOR, to study the property tax exemptions available to veterans under current law and make a report and recommendations to the legislature by the end of 2024.

Scholarship Conditions:


- Applicants must be employed by a town/city participating in the WCAA
